



Account to Account (A2A) Agreement Form

Authorization Agreement

By completing and signing this form, you authorize Academic Federal Credit Union to establish transfers from or to your ACADEMIC FEDERAL CREDIT UNION account. **Note: If form is incomplete, transfer will not occur.**

- One account must be an ACADEMIC FEDERAL CREDIT UNION account, and the other must be an account at another financial institution within the jurisdiction of the United States.
- You must be an owner of the “From” account.
- You may use this form to authorize transfers:
 - From your external account at another financial institution to pay an ACADEMIC FEDERAL CREDIT UNION loan and/or to establish transfers to an ACADEMIC FEDERAL CREDIT UNION share (savings) account, share draft (checking) account or money market account.
 - From your ACADEMIC FEDERAL CREDIT UNION account to an external account at another financial institution.
- Transfer requests will be processed on the day requested, unless the scheduled date falls on a weekend or federal holiday. In this event, the transfer will be made on the business day preceding the weekend or federal holiday, when possible. If the request is made on a weekend, the first transfer will occur on the first business day after the request. For transfers to an at another financial institution, we cannot guarantee when the receiving financial institution will make the funds available. Typically, the funds you are transferring will be available within three (3) business days.
- If the automatic transfer is returned for any reason, including non-sufficient funds, ACADEMIC FEDERAL CREDIT UNION may assess a fee as specified in ACADEMIC FEDERAL CREDIT UNION’s Schedule of Fees and Charges.
- Transfers to an account at another financial institution may be requested to a maximum of \$5,000 per calendar day and a maximum limit of \$30,000 over the last 30 days. Transfers into accounts at ACADEMIC FEDERAL CREDIT UNION are unlimited.

Further, you agree not to hold ACADEMIC FEDERAL CREDIT UNION responsible for any delay or loss of funds due to incorrect or incomplete information supplied by you, or by your financial institution, or due to an error on the part of your financial institution in depositing funds to or from your account.

PLEASE CONTINUE ON REVERSE SIDE

This agreement will remain in effect until ACADEMIC FEDERAL CREDIT UNION receives a written notice of cancellation from you.

ACADEMIC FEDERAL CREDIT UNION has the right to terminate this authorization agreement for any reason.
